Overview

How are telecoms regulated in Cyprus?

In Cyprus, the provision of telecoms (or electronic communications) networks and services is regulated by the OCECPR. Licensing: Providers must obtain licences to operate telecoms networks and services. Universal service obligations: Ensuring that basic telecom services are available to all residents at an affordable price.

Who regulates the use of radio spectrum in Cyprus?

In Cyprus, the DEC, under the Ministry of Transport, Communications and Works, regulates the use of the radio spectrum, ensuring its efficient management and public benefit.

What does the Cyprus Telecommunications Authority do?

It supervises the activities of the Cyprus Telecommunications Authority in accordance with the Telecommunications Services Law, on behalf of the Minister of Communications and Works. It provides consulting services on telecommunications matters to various Government Departments including the National Guard.

What is the regulation of high-speed broadband networks in Cyprus?

According to the regulation of high-speed broadband networks in Cyprus: Availability: Telecom operators must provide access to ducts and poles under fair, reasonable and non-discriminatory (FRAND) terms.
