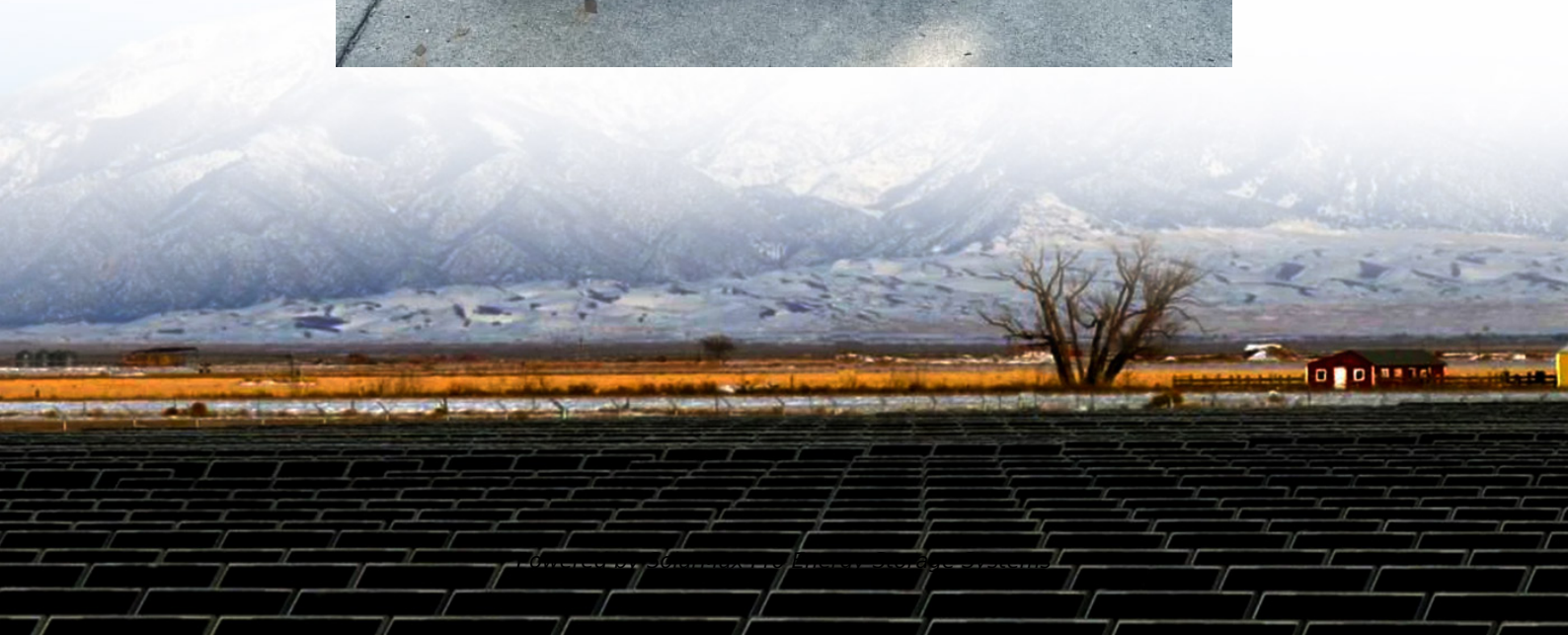

However, fires at some BESS installations have caused concern in communities considering BESS as a method to support their grids.

Renewables like wind and solar energy are intermittent by nature. To successfully master the energy transition, reliable energy storage systems are a must to provide the necessary supply stability.

Do I need a sprinkler system for a battery ESS?

A: Testing has shown that water is the most effective agent for cooling for a battery ESS. For this reason, a sprinkler system designed in accordance with NFPA 13, Standard for the Installation of Sprinkler Systems, is required by NFPA 855, Standard for the Installation of Energy Storage Systems.
