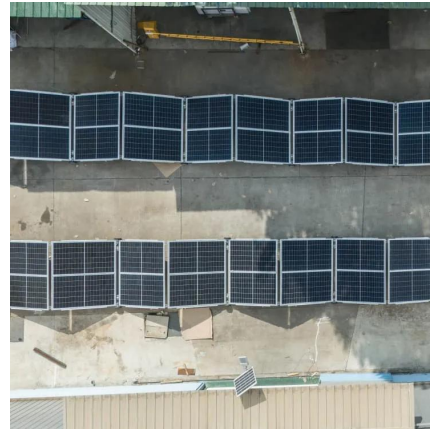

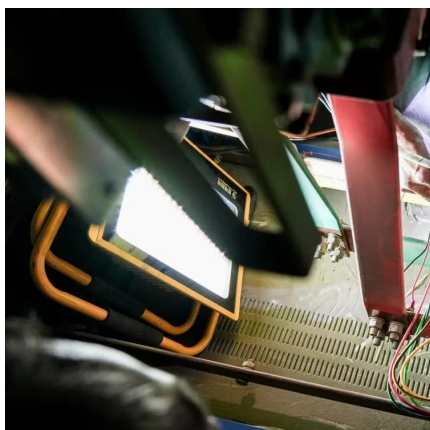

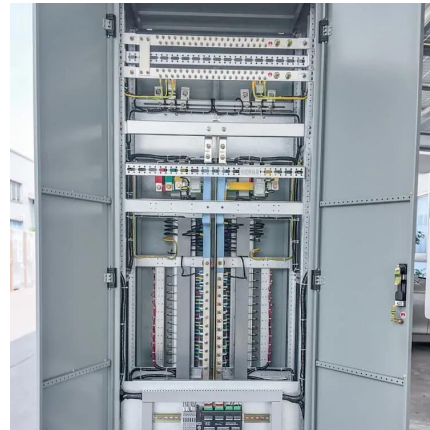
Myanmar Imports, Tariffs by country and region 2023 , WITS Data

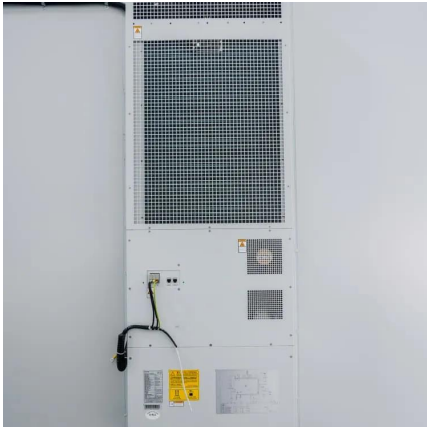
