# **New Zealand home battery BMS standard**





## Overview

---

Are batteries safe in New Zealand?

Yes. New Zealand has strict standards that apply to batteries including the location and installation. If these are followed, the risk of fires is very low. Can batteries be recycled?

Yes! 95% of a lithium battery has the potential to be recycled and second life battery manufacturing is occurring in New Zealand.

What is a battery management safety system?

The battery management safety system is designed to protect the lithium ion battery from potentially damaging situations. The BMPRO batteries referenced in section 9 of this document comply to IEC62619 and therefore can be installed in compliance with AS/NZS3001.2:2022. The battery management safety system is designed to protect the lithium ion battery from potentially damaging situations. Why is battery storage important in New Zealand?

Battery storage, from household to utility-scale batteries and within electric vehicles, is a game changer in the energy transition. Solar penetration is still low in New Zealand but it is growing quickly and if we want to make the most of it we need to capture and store it to be used when the sun isn't shining and when demand is at its highest.

Which battery chemistry is best for your home?



Battery chemistry: While lead-acid batteries used to be popular, especially in remote areas, the most widely available home batteries use lithium-ion chemistry (similar to the batteries in laptops and mobiles) because they are more efficient and have higher power for weight/volume.
